Service record book

All full members in the Yacht sector receive a free industry-leading service record book, approved by the UK Maritime & Coastguard Agency (MCA). The service record book assists members in recording and calculating their qualifying sea service for the purpose of certification. The book is administered by the Union and the process is verified and recognised by the MCA.

Legal services

With the maritime profession under increasing risk of criminalisation, Nautilus Legal offers members an extensive range of legal services provided by specialist lawyers in nearly 60 jurisdictions.

Certificate protection

Workplace support

Nautilus International officials provide expert advice on work-related problems such as contracts, redundancy, bullying or discrimination, non-payment of wages, and pensions.

Safety and welfare
